

VARIATION TO A CONTRACT

This variation to a Grant Agreement (hereinafter referred to as the "Variation") is entered into with effect from 20th May 2025 between Zinc Network Limited ("Customer") of 230 Blackfriars Road, London, SE1 8NW and Georgia's Reforms Associates incorporated and registered in Georgia with company number 406077579 whose registered office is at Aghmashenebeli Ave. №189, 3rd floor 0112, Tbilisi, Georgia.

Variation Conditions. This variation is by and between the Parties with regard to the Grant Agreement (LMOIP210) to provide services to the "Customer" with regard to its contract with the FCDO, to deliver *Climate and energy-related disinformation project*.

This variation shall amend a prior Grant Agreement between the two parties entered into as of 31st March 2025, a copy of which is attached. This is the 1st variation to the original Grant Agreement.

- 3) The original End Date "31st May 2025" will be removed and altered to "23rd May 2025."
